#### **Club Honours Policy**

#### 1. PURPOSE

The purpose of this policy is to provide a framework for the nomination, assessment and selection for Members of the Coogee Beach Surf Life Saving Club (SLSC) Honour Awards. It outlines the procedure by which nominations are processed as well as giving a broad set of criteria that shall be used when assessing the suitability of those members to be awarded Club Honours.

### 2. PRINCIPLE

To acknowledge the dedicated and selfless contribution of members who have provided:

- Outstanding contribution throughout the season in the delivery and development of Club Administration, Surf Life Saving and Surf Sports Activities.
- 2. Extensive years of distinguished voluntary service to the Club over a sustained period in various aspects of Club related activities which includes but is not limited to Governance, Beach Operations, Club Operations and participation in Club Events and Social Activities or by virtue of a Meritorious rescue performed by a member or members.
- Dedicated and selfless contribution of members who have provided extensive years of extraordinary voluntary service to the City of Cockburn by extending them the honour of being awarded life membership of the Coogee Beach SLSC

#### 3. SCOPE

This policy covers the Members of the Coogee Beach Surf Life Saving Club and is written to incorporate requirements of the Coogee Beach SLSC Constitution.

#### 4. DEFINITIONS

The definitions of the Coogee Beach SLSC Constitution are adopted within this policy.

#### 5. HONOURS PANEL

The Honours Panel shall be constituted by clauses within this policy and will meet within two (2) weeks of nominations closing and shall have the authority to award Club Honours and co-opt the services of other persons to provide advice and assistance on specific matters referring to the nomination.

Review the achievements of the nominees in accordance with the criteria set out in this policy and ensure that clarification and verifications of a nominee's achievements, activities, offices held, roles and responsibilities are provided in their assessment.

The Honours Panel doesn't have the authority or power to make decisions binding on the Board or Association.

Composition of the Honours Panel will be comprised of the (9) members detailed below, with a quorum of (5) required.

- Immediate Past President Chairperson
- Board of Directors Representative (Appointed annually by the Board of Directors)
- Club Member (Appointed annually by the Board of Directors)
- Life Members x 5

On awarding Club Honours the Honours Panel is responsible for compiling and submitting Club nominations for the SLSWA Awards of Excellence.

# SURF LIFE SAVING CLUB

#### **Club Honours Policy**

#### 5.1. RESPONSIBILITIES

- Honours Panel are required to produce minutes of any meeting held and must maintain confidentiality of nominees.
- Ensure that factual information and documented evidence regarding the nominee's achievements, offices held and so forth shall be sourced and verified. This may include, without limitation archival documentation in the form of minutes of meetings, annual reports, honour boards, certificates. Letters etc. Where this is not possible. Relevant information shall still be listed, and details provide.
- Honours Panel Chairperson shall ensure that clarification and verifications of a nominee's
  activities, offices held, roles and responsibilities are provided in their assessment. This is to
  allow the Panel to make an informed assessment of the nominee's achievements.
- Honours Panel to provide the Board of Directors a written submission of appointments of Life Membership for the Boards approval. The submission shall provide an overview of the assessment of the nominee's achievements, activities, offices held, roles and responsibilities
- Honours Panel Chair or a representative appointed by the Chair shall, at the request of but in the absolute of the Board, attend a scheduled Board meeting for clarification of an appointment.

### 5.2. NOMINATION, REVIEW AND AWARD PROCESS

The nomination, review and award of Life Membership shall be in line with the Constitution and its relevant clauses (Specifically 5.5 - Section C - Point 1.) The Constitution takes precedent over other procedures and documents.

Nomination closing dates for each honour will be set at the Board of Directors Annual Planning Day (held in July) and communicated to Members via the Club's Website and Members Handbook.

Nominations for the following Club Awards are compiled and submitted by Members of the Club, members can submit one nomination per award category:

- Geoff Newman Club Person of the Year
- Junior Club Person of the Year
- City of Cockburn Lifesaver of the Year (Senior)
- John Bate Junior Lifesaver of the Year
- Lifesaving Family of the Year
- Dave Knowles Excellence in Education
- Competitor of the Year (Junior, Youth, Senior and Masters)
- Team of the Year (Junior, Youth, Senior and Masters)
- Scott & Michelle McKee Boat Person of the Year
- Coach of the Year

Details of the nomination process are defined in:

- Attachment 3 Club Person of the Year Award Nomination Form
- Attachment 4 Club Awards Nomination Form Lifesaving
- Attachment 5 Club Award Nomination Form Member Development
- Attachment 6 Club Awards Nomination Form Surf Sports

Nominations once received are forwarded onto the respective Selection Committees who will review and select three (3) nominations to be forwarded onto the Honours Panels for awarding.

If there are no nominations submitted by the requested due date for an honour, the honour will not be awarded for that particular season.

### 6. HONOURS

#### 6.1. LIFE MEMBERSHIP

Life Membership is the highest award available to be bestowed upon an individual of the Coogee Beach Surf Life Saving Club. Life Membership recognises the exceptional and extraordinary voluntary contribution of an individual to the Coogee Beach Surf Life Saving Club.

- Nomination is to follow the Life Membership Process Flow. (Attachment 1)
- Nomination shall be on the correct form, (Attachment 2) the form shall be in hard copy and addressed to the President under confidential cover.
- Nomination shall be made by any two (2) financial members of the Association.
- If a nomination is unsuccessful it is able to be updated and resubmitted for consideration after a minimum of two (2) years from the date the final motion if rejected.
- The onus is on those Members nominating the Member for life membership to provide all relevant information and documentation in support of the nomination.

#### **CRITERIA**

The Constitution (Section 5.5 - Section C - Point 1.) contains the basic criteria for the award of Life Membership. In additional to this, the following conditions and criteria shall be used by the Honours Panel, Board of Directors and General Membership in the nomination and assessment of whether a member should be awarded Life Membership.

- At least fifteen (15) years' service, the voluntary service rendered and the achievements during that period must be considered as extraordinary.
- Consistent, sustained, exceptional and extraordinary voluntary service or achievement and exemplary contribution that is beyond what is expected of Association Members.
- The service and achievement must primarily be for the benefit and/or advancement of the Association. Service and achievements within SLSWA or SLSA may also be considered as contribution to the nomination.
- Contributions made by the nominee to the Association can be wide and varied and all of these must be considered, the number, type of positions, demands of each position and the period for which they were held should all be considered.
- Competitive record including local. State and/or National representation may be also be considered as contributing to the nomination of Life Membership.
- The nominee shall have shown to have abided by the Code of Conduct of SLSA, SLSWA and the Coogee Beach SLSC. The nominee must have exhibited professional, ethical and positive conduct during their Membership of the Association.
- In special and extenuating circumstances, the Honours Panel by unanimous decision may recommend to the Board of Directors, Life Membership of the Club to any member who warrants this honour due to rendering special and outstanding service to the Club, without the requirement of fifth teen (15) year's membership, but this would be for exceptional circumstances only, and must not be for more than one nomination per annum.

#### 6.2. DISTINGUISHED SERVICE AWARD

To acknowledge members who have rendered distinguished service to the Club over a sustained period (no less than 10 years of service) in various aspects of Club related activities which includes but is not limited to Governance, Beach Operations, Club Operations and participation in Club Events and Social Activities or by virtue of a Meritorious rescue performed by a member or members.

A maximum of 6 distinguished service awards may be issued in any one season. The Honours Panel shall be responsible for identifying and recommending members for the award to the Board of Directors.

# COOGEE BEACH

#### **Club Honours Policy**

#### **CRITERIA**

- At least ten (10) years' service rendered in various aspects of Club related activities which includes but is not limited to Governance, Beach Operations and Club Operations.
- The number and types of positions held and the period for which they were held.
- Participation in Club Events and Social Activities. (i.e. Fundraising activities and Club Open Days)
- Meritorious rescue performed.

#### **REFERENCES**

- Governance: Board of Directors
- Beach Operations: Lifesaving, Member Development, Surf Sports
- Club Operations: Administration, Club Development, Marketing
- In determining a member's qualification for this award, the Honours Panel will consider the seniority of each position held as follows:
  - 1. Director
  - 2. Patrol Captain & Age Group Manager
  - 3. Coordinator & Vice Patrol Captain
  - 4. Club Officer
  - 5. Patrolling Member

The panel will have the complete discretion to determine a member's qualification as it sees fit.

#### **AWARD PROCESS**

The Director of Administration will run a report annually (February) in SurfGuard to identify members with service greater than 10 years of service.

Report to be forwarded to the Honours Panel Chairperson who will populate any missing data and present the report to the Honours Panel for evaluation and award. (members may also be nominated for life membership if service is deemed as exceptional service to the Club)

Honours Panel Chairperson to present the Honours Panel recommendations to the Board of Directors for approval.

#### 6.3. CLUB PERSON OF THE YEAR

The Geoff Newman Club and the Junior Club Person (awarded to member within the age group Under 8's to Cadets) of the Year Awards are the highest awards available to be bestowed upon an individuals of the Coogee Beach Surf Life Saving Club in a season.

Recognise an individual member/s who has demonstrated achievements in a range of different areas of the club throughout the season, or who has shown significant and outstanding achievements in one particular area for an extended duration. The individual's contribution demonstrably enhances the development of the Club.

A nominee may be a Member in any area of the Club including but not limited to Club Administration, Lifesaving and Surf Sports. The nomination, review and selection of the Club Person of the Year Award shall be in line with the relevant clauses in the Club Honours Policy and takes precedent over other procedures and documents.

• Director Life Saving (Chair), Chief Patrol Officer and Club Captain.

#### 6.4.1. LIFESAVER OF THE YEAR

#### CRITERIA

- Individual contribution and commitment made to surf lifesaving patrol duties.
- Demonstrated commitment to public and community safety.
- Positions held relevant to lifesaving, held at Club, State and National levels.
- Awards achieved relevant to surf lifesaving duties.
- Attended conferences and participated in professional development relating to education.

#### **CATEGORIES**

- John Bate Junior Life Saver of the Year
- City of Cockburn Life Saver of the Year

- SurfGuard is the official record of patrol hours; prior to the recording of patrol hours in SurfGuard, manual patrol logs are the official source.
- Eligible candidates shall meet the requirements regarding their conduct and remain in good standing with the Club as outlined in CB040 Members Code of Conduct.

#### 6.5.1. EXCELLENCE IN EDUCATION

Dave Knowles Excellence in Education n Award recognises and rewards members who have made a significant contribution towards the area of education and awards within surf lifesaving and the community.

#### **CRITERIA**

- Contribution and commitment made to surf lifesaving training and assessment duties within the Club and Community.
- Contributed to the continuous improvement of new training resources and tools.
- Positions held relevant to education, held at Club, State and National levels.
- Awards achieved relevant to education duties.
- Attended conferences and participated in professional development relating to education.

### 6.6. SURF SPORTS

Recognises and rewards individual members and teams who have made a significant contribution towards the area of Surf Sports within the Club and the Association in regards to:

- Individual performances throughout the course of the season.
- Significant contribution towards the area of team events and performances.
- Significant contribution towards the area of coaching in regards to both athlete/s performance and the area of coaching educational development within the Club.
- Outstanding contribution to the delivery and development of surf boats and can be presented as an identifiable "Ambassadors" for surf boats within the Club and the Association.

It is recognised that assessment of a nomination in relation to all criteria is ultimately a subjective process. This is due to the assessment being made by individuals who may have differing values and beliefs.



#### Life Membership Nomination

- On specified form
- Basic evidence/reasons as per form requirements
- Nominated by two (2) current financial members
- Addressed to the President of the Board
- Form available on website

#### Received by Board

- Receipt of nomination noted in Board Meeting Minutes.
- Brief reply letter to the primary nominator to be compiled and signed by the President indicating that the nomination has been received.
- Nomination forwarded to Honours Panel Chairperson with a brief from the President directing the Honours Panel to review the nomination within the guidelines of the Constitution and Honours Policy.

#### **Nomination Reviewed by Honours Panel**

- Honours Panel meets to review nomination and assess it in accordance with the Constitution and Honours Policy
- Obtains and documents proof/evidence from a number of resources:
  - o Annual Reports
  - o Awards Lists
  - o Surfguard
  - SLSWA records of any type
  - o Interview of nominators
  - Interview of other club members as required
- Assessment compiled:
  - Basis for recommendation
  - List of evidence obtained plus copies of any documents
  - Brief minutes/summary of any interviews held
- Appointment/Rejected

#### Approval by the Board

- Honours Panel Chairperson presents appointment assessment/s to the Board of Directors, noted in Board Meeting Minutes.
- General discussion held on appointment/s.
- If the Honours Panel Chairperson can't provide clarification on any questions raised by the Board, the appointment assessment/s will be directed back to Honours Panel for further validation.
- If the Board of Directors are comfortable with the appointment assessment/s the President with table a motion for the Board of Directors to approve the appointment/s.
- Outcome minuted in meeting minutes

#### Approved

 Letter drafted and forward to the nominee, explaining their nomination and asking is they would be willing to accept, following the Constitution and Club Honours Policy.

#### Rejected

- Archive all documentation
- Able to be resubmitted after two (2) years for reconsideration

Nomination for Life Membership to be considered by the Coogee Beach SLSC Board must be completed on this form.

The following policy information is relevant to selection criteria. Please read this information and address the appropriate areas in your nomination. Other supporting information may be attached.

Coogee Beach SLSC Constitution Clause 5.6 (d) A Member suitable for Life Membership is any natural person who has rendered distinguished service to the Association and Surf Life Saving, where such service is deemed to have assisted the advancement of the Association and Surf Life Saving in the City of Cockburn.

In additional to this, the following conditions and criteria in the "Honours Policy" shall be used by the Honours Penal, Board and General Membership in the assessment of whether a nominee should be awarded with Life Membership.

- The voluntary service rendered and the achievements during that period must be considered as distinguished.
- Consistent, sustained and dedicated service or achievement and exemplary contribution that is beyond what is expected of Association Members.
- The service and achievement must primarily be for the benefit and/or advancement of the Association. Service and achievements within SLSWA or SLSA may also be considered as a contribution to the person's nominations.
- 4. The contributions made by the nominee to the Association can be wide and varied and these must be considered. The number, types of positions, demands of each position and the period for which they were held should all be considered.
